

# REPORT ON CASES OF VIOLENCE AND VIOLATIONS BASED ON REAL OR PRESUMED SEXUAL ORIENTATION AND/ OR GENDER IDENTITY DURING THE MONTH OF NOVEMBER 2023

#### 1. Introduction

The Anti Homosexuality Act has, as at the end of November 2023, been in force for a period of six months. Human Rights Awareness and Promotion Forum (HRAPF) has continued to document cases of violence and human rights violations based on real or presumed sexual orientation or gender identity and expression (SOGIE) and has published monthly reports for every month since the AHA came into force. This is the report of the sixth month of the AHA's enforcement, featuring cases reported to HRAPF's legal aid network in the month of November 2023 in which known or suspected LGBTQ persons were targeted for violence and violations on the basis of their SOGIE. The report also contains an overview of the cases of violence and violations recorded over the six-month period, as well as a comparison with the same period (November) last year (2022).

## 2. Methodology

As with previous reports in this series, the report provides an overview of reported cases of violence and human rights violations on the basis of SOGIE that were reported to and handled by the HRAPF legal aid clinic in the month of November 2023. The report employs both qualitative and quantitative methods of data collection to collect and analyse the data shared in this report.

Quantitative data was obtained from a review of case files to ascertain the number of cases handled and the cases in which the particular incidents of violence and violations reported herein occurred. This data was then subjected to a further in-depth qualitative analysis to ascertain the circumstances under which the incidents occurred. Only cases in which there is reason to believe that the actions in the incidents deliberately targeted LGBTIQ persons primarily or wholly on the basis of their real or presumed sexual orientation and/or gender identity are included in the report.

A recurring limitation of this report is that it contains only cases that have been reported to HRAPF through our legal aid network, which consists of the main legal aid clinic in Kampala, regional legal aid centres, specialised legal aid desks, and the network of over 200 community paralegals spread across the country. This network is spread out enough to cover the majority of the districts in the country and all regions, but it is worth noting that there may indeed be areas where cases are not reported at all, thus limiting the data available for this report. HRAPF also recognises that some cases could have been reported to other legal providers. This report therefore presents an accurate picture of the situation for LGBTIQ persons as reported to HRAPF, but may not necessarily be representative of the situation for all LGBTIQ persons across the country.

# 3. Nature and number of cases reported

HRAPF handled a total of 69 cases involving LGBTIQ persons in the month of November 2023. This was a notable decrease from the 83 cases registered in October 2023. Out of the 69 cases handled, 39 cases involved actions that directly targeted people for negative treatment on the basis of their SOGIE, representing 56.95% of all the cases handled during the month of November 2023. This is a

39% decrease from the 64 cases recorded in October 2023. These cases affected 44 persons compared to 85 in October 2023, a decrease by almost one half.

Out of the 39 cases in which LGBTIQ people were specifically targeted for detrimental treatment, 20 were cases of unlawful evictions from rented properties affecting 24 persons, 9 were cases of violence and threats of violence affecting 10 persons, 7 were arrests for sexuality-related reasons affecting 7 persons while 3 were civil matters reported by LGBTI persons where they had been discriminated due to their sexuality, affecting 3 persons. This section of the report provides detailed data on these cases.

### 3.1 Evictions from property and communities

There were 20 cases of unlawful evictions from rented property that were reported to HRAPF's legal aid clinic, affecting 24 persons. The cases were reported from the districts of Kampala (9), Wakiso (6), Gulu (3) and Mbale (1). The evictions were perpetrated primarily by the property owners/ landlords (15), followed by local council authorities working with landlords and the general community (4) and family members (3). In many of these cases, the neighbours expressed suspicion about the victims' sexuality, prompting the landlords to evict the clients.

#### 3.2 Cases of violence

HRAPF recorded a remarkable reduction in the number of cases involving actual or threatened violence based on real or presumed sexual orientation in November 2023 compared to October 2023 and earlier months. In November 2023, 8 cases were registered affecting 8 persons, while there were 28 of these in October 2023 – a notable 71.4% decrease.

# i) Cases of actual violence on the basis of sexual orientation/gender identity

There were 5 cases of actual violence against persons on the basis of their real or presumed SOGIE in November 2023, affecting 5 persons. This violence was perpetrated by unknown persons in 3 cases and in 2 cases by known family members. Physical assaults were involved in 4 cases and verbal assaults in 1 case.

Out of the 5 cases, 3 cases happened in Kampala while 1 case happened in Rukungiri district, and 1 in Kole district.

# ii) Cases involving threats of violence based on sexual orientation and/or gender identity

A total of 4 cases involving threats of violence against persons on the basis of their real or presumed SOGIE were reported in November 2023, affecting 4 persons. These threats were primarily threats of physical violence.

The threats were perpetrated by the general community in 2 cases, neighbours in one case and family members in one case. All these cases were registered in Kampala district.

#### 3.3 Cases of arrest

In November 2023, HRAPF handled a total of 7 cases in which individuals were arrested on sexuality related charges. These are compared to 6 cases involving 10 individuals handled in October. Out of the 7 cases, 4 were charged with offences under the AHA, and 2 were taken to court while 2 were released on police bond. In the two cases that went to court, one was charged with aggravated homosexuality at Makindye Chief Magistrates Court while the other charged with homosexuality at Mbale Chief Magistrates Court. For the other 2 cases which are still at police, the 2 clients were released on police bond, from Hoima and Iganga districts.

Three people were arrested on sexuality related charges which are under the Penal Code and not under the AHA. Of these, 1 person was charged with indecent practices in Kampala, 1 charged with procuring unnatural offences in Buikwe and 1 person was arrested due to her sexuality but there were no charges preferred against her in Kampala.

A total of 7 individuals were affected in these cases, as illustrated in the table below.

# 3.4 Other cases reported by clients

During the month of November 2023, 3 clients reported other challenges they had faced due to their sexuality, specifically matters of discrimination, and the details of their cases are elaborated below.

### 4. Comparison with October 2023

There has been a reduction in the number of cases reported overall as well as the number of cases involving actions that deliberately targeted persons for negative treatment on the basis of their real or presumed SOGIE. In October 2023, a total of 83 cases involving LGBTIQ persons were reported across our networks as compared to 69 in November 2023, a reduction of 16.8%. In terms of cases that specifically targeted individuals on the basis of their SOGIE, there was a reduction from 64 cases affecting 85 persons to 39 cases affecting 44 persons in November 2023.

In both months, the highest number of cases registered were evictions, with 20 cases of evictions affecting 24 persons in November and 28 evictions affecting 37 persons in October 2023. The cases of violence and threats of violence reduced drastically from 27 cases affecting 35 persons in October 2023 to 9 cases affecting 10 persons in November 2023. It is also important to note that cases of arrests on sexuality related charges increased from 6 in October to 7 in November 2023 affecting 7 persons, although there were more people affected (10) in October, compared to the 7 in November.

### 5. Comparison with the period from 1st November 2022 to 31st November 2022

In November 2022, a total of 39 cases were handled involving LGBTIQ persons, of which 10 cases involved actions that directly targeted persons on the basis of their real or presumed SOGIE. The cases involved 5 incidents of real or threatened violence and 5 evictions. There were no sexuality-related arrests in the period.

The total number of cases handled in November 2023 increased from the same period in 2022, from 39 to 69, as has the number of cases in which individuals have been targeted for detrimental treatment on the basis of their sexuality, from 10 cases in November 2022 to 39 cases in November 2023. This increase can be attributed to the enforcement of the AHA in 2023.

### 6. The first six months of the AHA 2023 in Uganda

In the first six months of the AHA 2023, a total of 436 cases involving LGBTQ persons have been handled across the legal aid network, of which 299 (67.95%) targeted LGBTIQ people on the basis of their sexuality, affecting a total of 379 persons. The breakdown of cases so far is as follows:

In comparison with the same 6-months period in 2022, a total of 230 LGBTIQ cases were handled in that period, of which 79 cases (34.3%) contained actions that deliberately targeted LGBTIQ persons for detrimental treatment. This translates to an increase of 206 in the overall total number of cases handled, from 230 in June to November 2022 to 436 cases in the period from June to November 2023, and an increase of 220 (91.3%) in the number of cases involving actions targeting LGBTQ persons specifically, from 79 in June to November 2022 to 299 in June to November 2023, a 278% increase.

It is thus reasonable to infer that nearly all the cases by which the general case load has been increased are in fact homophobia-driven incidents that could be directly attributed to the enactment of the AHA.

#### 7. Conclusion

It is clear that the situation for LGBTQ persons in Uganda in the wake of the enactment of the AHA continues to be particularly difficult, with cases of deliberate and targeted homophobia continuing to affect several individuals as discussed above. Arrests also continue and people continue to be charged under the Anti-Homosexuality Act 2023, and under the Penal Code Act. Cases of violence have drastically reduced in the past one month, but we are yet to see if the trend holds in December 2023.
