1. Introduction

The Anti Homosexuality Act, 2023 has, as at the end of December 2023, been in force for a period of seven months. Human Rights Awareness and Promotion Forum (HRAPF) has continued to monitor the human rights situation and lived realities of LGBTIQ

persons in the wake of the passing of the Anti-Homosexuality Act (AHA) and its subsequent enforcement, and to document cases of violence and human rights violations based on real or presumed sexual orientation or gender identity. HRAPF documents and reports on cases reported to and handled by HRAPF's legal aid clinic, and has published monthly reports on this data for every month. This is the report of the seventh month of the AHA's enforcement, exploring cases reported in the month of December 2023 in which known or suspected LGBTIQ persons were targeted for violence and violations purely on the basis of their sexual orientation and gender identity or expression (SOGIE). This report builds on the reports produced earlier in this series and therefore seeks to build on the data available about the enforcement of the AHA 2023 from the 30th of May 2023 (when the AHA came into force) to date.

2. Methodology

As with previous reports in this series, this report provides an overview of reported cases of violence and human rights violations on the basis of SOGIE that were reported to and handled by the HRAPF legal aid clinic in the month of December 2023. The report employs both qualitative and quantitative methods of data collection to collect and analyse the data shared in this report.

Quantitative data was obtained from a review of case files to ascertain the number of cases handled and the cases in which the particular incidents of violence and violations reported herein occurred. This data was then subjected to a further indepth qualitative analysis to ascertain the circumstances under which the incidents occurred. Only cases in which there is reason to believe that the actions in the incidents deliberately targeted LGBTQ persons primarily or wholly on the basis of their real or presumed sexuality are included in the report.

This report contains only cases that have been reported to HRAPF through our countrywide network of community paralegals, regional legal aid centres, specialised legal aid desks and the central legal aid clinic. This network is spread out enough to cover the majority of the districts in the country and all regions, but it is worth noting that there may indeed be areas where cases are not reported at all, thus limiting the data available for this report. HRAPF also recognises that not all cases that occurred in the month of December were reported to HRAPF and that some may not have been reported at all. This report therefore presents a fair picture of the situation for LGBTIQ persons as reported to HRAPF, but may not necessarily be representative of the lived realities of all LGBTQ persons across the country.

3. Nature and number of cases reported

HRAPF handled a total of 83 cases in the month of December 2023, marking an increase of 57.3% from the 69 cases handled in November 2023. Out of the 83 cases handled, 47 cases involved actions that directly targeted people for negative treatment on the basis of their SOGIE, representing 56.6% of all the cases handled during the month of December 2023, which is about the same percentage as was noted in November 2023 (56.95%).

Out of the 47 cases in which LGBTQ people were specifically targeted for detrimental treatment during the month of December 2023, 27 were cases of unlawful evictions from rented properties and villages of residence, 14 were cases of violence and threats of violence and 6 were arrests for sexuality-related reasons. These actions affected a total of 62 individuals.

This section of the report provides detailed data on these cases.

3.1 Evictions from rented property

In December 2023, there were 27 cases of unlawful evictions from rented property that were reported to HRAPF's legal aid clinic, affecting 33 persons. The cases were reported from the districts of Wakiso (13), Kampala (9), Jinja (2), Gulu (1), Mbarara (1), and Mukono (1). The evictions were perpetrated primarily by the property owners/ landlords (18), followed by local council authorities working with the property owners (6), local leaders working with the general community (2), and family members (1). In many of these cases, the neighbors expressed suspicion and discomfort about the victim's sexuality, prompting the landlords and local area leaders to evict the clients.

3.2 Cases of violence

There has been an increase in the number of cases of actual violence and threats of violence against individuals on basis of their real or/ presumed SOGIE. In December 2023, 14 cases were registered, affecting 20 persons, while in November 2023, 9 cases were registered affecting 9 persons. The number is however lower than the cases recorded in October, in which 28 cases involving violence and threats against individuals on the basis of their SOGIE were registered.

i) Cases of actual violence on the basis of sexual orientation/gender identity

There were 10 cases of actual violence against persons on the basis of their real or presumed SOGIE in December 2023, affecting 13 persons. This violence was perpetrated by unknown persons in 5 cases and in 5 cases by known members of the communities in which the victims reside. Physical assaults were involved in 8 cases while in 1 case, the victim's household property was destroyed and in the other the victim was subjected to cyber harassment.

Out of the 10 cases, 4 cases happened in Wakiso, 2 cases in Kampala, 2 cases in Arua, 1 case in Mbale and 1 case in Gulu district.

i) Cases involving threats of violence based on sexual orientation and/or gender identity

A total of 4 cases involving threats of violence against persons on the basis of their real or presumed SOGIE were reported in December 2023, affecting 7 persons. These threats were primarily threats of physical violence.

In all the 7 cases, the threats were perpetrated by members of the general community against the clients.

3.3 Cases of arrest

In December 2023, HRAPF handled a total of 6 cases in which individuals were arrested on sexuality related charges. Out of the 6 cases, 3 were charged with offences under the AHA. The 3 clients in all three cases in which charges were preferred under the AHA were released on police bond from Katwe Police Division Headquarters, Kibiri Police Station and Soroti Police station.

In the other 3 cases, the clients in 2 of the cases were released on bail by court (Busia and Makindye) while in 1 case, the client was granted police bond. All these cases are still pending.

A total of 9 individuals were affected in these cases, as illustrated in the table below.

5. Comparison with November 2023

There has been an increase in the number of cases reported overall as well as the number of cases involving actions that deliberately targeted persons for negative treatment on the basis of their real or presumed SOGIE. In November 2023, a total of 69 cases involving LGBTQ persons were reported across our networks while in December 2023, 83 cases were reported, marking an increase of 8.3%. In terms of cases that specifically targeted individuals on the basis of their SOGIE, there was an increase from 42 cases affecting 47 persons in November to 47 cases affecting 62 persons in December 2023.

In both months, the highest number of cases registered were evictions, with 20 evictions affecting 25 persons in November 2023 and 27 evictions affecting 33 persons in December 2023. The cases of violence and threats of violence increased from 9 cases affecting 9 persons in November 2023 to 14 cases affecting 20 persons in December 2023. It is however interesting to note that cases of arrests on sexuality related charges reduced from 9 in November affecting 9 persons to 6 in December 2023, affecting 9 persons.

6. Comparison with the period from 1st December 2022 to 31st December 2022

In November 2022, a total of 42 cases were handled involving LGBTIQ persons, of which 12 cases involved actions that directly targeted persons on the basis of their real or presumed SOGIE. The actions in these cases affected a total of 56 people, and included 6 cases of real or threatened violence and there was only 1 arrest.

The total number of cases handled in December 2023 has increased dramatically from the same period in 2022, from 42 to 83, as has the number of cases in which individuals have been targeted for detrimental treatment on the basis of their sexuality, from 12 cases in December 2022 to 47 cases in December 2023, an increase that can only be attributed to the AHA 2023.

8. The first seven months of the AHA 2023 in Uganda

In the first seven months of the AHA 2023, a total of 523 cases involving LGBTQ persons have been handled across the legal aid network, of which 349 (66.7%) targeted LGBTIQ people on the basis of their sexuality, affecting a total of 440 persons. The breakdown of cases so far is as follows:

In comparison with the same 7-months period in 2022, a total of 272 LGBTIQ cases were handled in that period, of which 91 cases (33.6%) contained actions that deliberately targeted LGBTIQ persons for detrimental treatment on the basis of their SOGIE. This translates to an increase of 251 cases in the overall total number of cases handled, from 272 cases in June to December 2022 to 523 cases in the period from June to November 2023, and an increase of 263 in the number of cases involving actions targeting LGBTQ persons specifically, from 91 cases in June to December 2022 to 354 cases in June to December 2023. This points to the conclusion that nearly all the cases by which the general case load has been increased are in fact homophobia-driven incidents that could be directly attributed to the enactment of the AHA.

9. Conclusion

While the Anti Homosexuality Act, 2023 has only been in force for 7 months, it is worth noting that, throughout the year 2023, discussion and debate around homosexuality, LGBTQ rights, transgenderism and intersexuality have taken centre stage in the national psyche, and therefore significantly affected the lives of LGBTIQ persons across all spheres of life. The public debate and political rhetoric around LGBTIQ rights, which started with statements made by the Deputy Speaker on the floor of Parliament in January 2023, sparked a public hysteria and moral panic that resulted in the enactment of the AHA. The impact on the rights of LGBTQ persons that this entire year has had is clearly visible at a glance: a total of 875 cases involving LGBTIQ persons were handled across all our networks in 2023, in which 949 persons were affected, as compared to 2022, during which 599 cases affecting 733 individuals were handled.

The cases which involved actions that directly targeted persons on the basis of their real or presumed SOGIE increased from 132 cases affecting 153 persons in 2022 to 416 cases affecting 522 persons in 2023. The cases of violence and threats of violence on the basis of SOGIE increased from 45 in 2022 to 175 in 2023; cases of evictions increased from 43 in 2022 to 181 in 2023, and arrests on sexuality related charges also increased from 34 cases in 2022 to 52 cases in 2023.

The increase in the number of cases, as has been noted from the monthly report series, is directly attributable to the increase in homophobic hate and violence during the year just concluded, a situation that grows ever more difficult for LGBTIQ persons to navigate.
