## **1. Introduction**

This is the 25<sup>th</sup> monthly report on violence and other forms of human rights violations on the basis of sexual orientation and gender identity/expression since the Anti-Homosexuality Act (AHA) came into force on 30<sup>th</sup> May 2023. The report discusses cases in which known or suspected LGBTIQ persons were targeted for violence and violations purely on the basis of their SOGIE as reported in the month of June 2025, and a comparison is made with the month of May 2025. This report builds on the reports produced earlier in this series and therefore seeks to build on the data available about the enforcement of the AHA 2023 from 30<sup>th</sup> May 2023 to date.

## **2. Methodology**

This report provides an overview of cases of violence and human rights violations on the basis of SOGIE that were reported to the HRAPF legal aid network during the month of June 2025. Quantitative data for this report was obtained from a review of case files for data on the number of cases handled and the number of cases in which acts of violence or other human rights violations were identified. The data was then subjected to a qualitative analysis to ascertain the circumstances under which the incidents occurred, in order to ensure that only cases in which such acts were perpetrated purely or primarily on the basis of real or presumed SOGIE are included in the report. All data reported has been independently verified to ensure its accuracy.

The data presented in this report is limited by the fact that it covers only cases reported through the HRAPF legal aid network. The report presents a fair picture of the situation for LGBTIQ persons across the country as reported to HRAPF's countrywide network of community paralegals, regional legal aid centres, specialised community legal aid desks and the main legal aid clinic, but it may not be representative of all LGBTIQ persons' lived realities during the month, as we acknowledge that not all cases that occurred in June 2025 were reported to HRAPF's network.

## **3. Nature and number of cases reported**

HRAPF handled a total of 57 cases in the month of June 2025, a slight increase from the 51 cases handled in the month of May 2025. Out of the 57 cases handled, 19 cases involved actions that directly targeted people for negative treatment on the basis of their SOGIE, representing 38.0% of all the cases handled during the month of June 2025. This represents a slight increase from May 2025, where 16 cases were registered where people were targeted for negative treatment on the basis of their SOGIE. A total of 60 persons were affected by the violations in June 2025 as compared to 19 people in May 2025. Out of the 19 cases in which LGBTIQ people were specifically targeted for violent or otherwise detrimental treatment during the month of June 2025, 7 were eviction cases, 6 cases involved arrests for sexuality related reasons, 5 cases involved violence and threats of violence against victims due to their actual or presumed SOGIE while 1 case involved confiscation of the client's property due to their SOGIE.

This section of the report provides detailed data on these cases.

### 3.1. Evictions

There were 7 cases of evictions on the basis of sexuality in June 2025, affecting 8 persons, reported in the districts of Kampala (4) and 1 case each in the districts of Mbale, Masaka and Mbarara. The evictions were executed by the clients' landlords in 4 cases, family members in 2 cases and the landlord in collaboration with the local area leadership in 1 case.

### 3.2. Arrests

There was an increase in the number of arrests for sexuality related reasons registered in June 2025, at 6 cases affecting 44 persons, as compared to May, where 3 cases were registered, affecting 5 persons. The drastic increase in the number of persons affected by the arrests was as a result of a police raid at a popular gay-friendly bar along Entebbe Road during which over 50 revellers were arrested on suspicions of homosexuality.

In 3 cases, the clients were charged with homosexuality under the Anti- Homosexuality Act; in 1 case, the client was charged with aggravated homosexuality (and eventually arraigned in court); in one case, the client was charged with being a common nuisance under the Penal Code Act while in 1 case, no charges were preferred against the victims at all, and they were released unconditionally. Five of these cases were closed at police and one case proceeded to court. 5 of these cases were registered in Kampala and 1 was registered in Wakiso.

### 3.3. Cases involving actual violence and threats of violence

A total of 5 cases involving violence and threats of violence were registered in June 2025, affecting 7 individuals. 4 of the cases reported in June 2025, involved actual violence being directed towards the victims due to their SOGIE while 1 case involved threats of violence as opposed to May 2025, where all cases involved physical violence.

#### *Cases involving actual violence*

There were 4 reported cases of actual violence in June 2025, affecting 6 individuals. 3 of these cases involved physical assaults and 1 involved a rape. 2 of the cases were reported in Gulu, 1 case in Kampala and 1 in Mukono. All these incidents were perpetrated by unknown persons.

### *Threats of violence*

There was one reported incident of a threat of violence in the month of June 2025, affecting 1 person. This case was reported in Kampala district, and involved a threat of lynching, perpetrated by the victim's neighbours.

### **3.4. Other forms of discrimination**

During the month of June 2025, one case of deprivation of property was recorded in Wakiso district, perpetrated by the victim's landlord.

**4. Comparison with May 2025**

There was a slight increase in the overall number of cases reported in June 2025, from 51 cases in May 2025 to 57 cases in June 2025. The number of cases involving actions that deliberately targeted persons for negative treatment on the basis of their real or presumed SOGIE also increased from 16 cases in May 2025 to 19 cases in June 2025, and the number of victims increased from 19 persons in May 2025 to 60 persons in June 2025. Eviction cases were the highest number of cases registered in both months, at 9 incidents in May and 7 in June 2025. Cases of violence and threats of violence slightly increased from 4 cases affecting 4 individuals in May 2025 to 5 cases affecting 7 individuals in June 2025. Arrests on sexuality related charges doubled from 3 cases affecting 5 persons in May 2025, to 6 cases affecting 44 persons in June 2025. The drastic increase in the number of persons affected by the arrests for sexuality related reasons was the raid at a gay-friendly bar in which more than 50 people were arrested on suspicion that they were LGBTQ persons.

**5. Comparison with June 2024**

In June 2024, HRAPF handled a total of 81 cases involving LGBTIQ persons. Out of these, 32 cases involved actions that directly targeted people for negative treatment on the basis of their SOGIE, representing 39.5% of all the cases handled during the month of June 2024, and 34 persons were affected by the violations. Out of the 32 cases in which LGBTIQ people were specifically targeted for detrimental treatment during the month of June 2024, 15 cases involved violence and threats of violence against persons on the basis of their SOGIE, 12 were eviction cases while 5 cases involved arrests for sexuality-related reasons.

In June 2025, a total of 57 cases were handled affecting LGBTIQ persons. Of these, 19 cases involved actions that directly targeted people for negative treatment on the basis of their SOGIE, representing 38.0% of all the cases handled during the month of June 2025. Out of the 19 cases in which LGBTIQ people were specifically targeted for violent or otherwise detrimental treatment during the month of June 2025, 7 were eviction cases, 6 cases involved arrests for sexuality related reasons, 5 cases involved violence and threats of violence being targeted against victims due to their actual or presumed SOGIE while 1 case involved confiscation of the client's property due to her SOGIE.

#### 6. The implementation of the AHA 2023 from 30<sup>th</sup> May 2023 to 30<sup>th</sup> June 2025

As the implementation of the AHA marks the 25 months, a total of 1,800 cases involving LGBTIQ persons have been handled across the HRAPF legal aid network, of which 863 cases (48.4%) involved actions that specifically targeted LGBTIQ people on the basis of their sexuality, affecting a total of 1,134 persons.

The breakdown of all the cases by month so far is as follows:

## 7. Conclusion

The continued implementation of the AHA has negatively impacted on the rights of LGBTIQ persons. This has majorly been manifested through the increasing number of eviction cases for sexuality related reasons, arbitrary arrests for persons suspected to be homosexuals, violence and threats of violence directly being targeted against LGBTIQ persons and all the other forms of discrimination reported in these series. It is important that the AHA and all the laws which are aimed at curtailing the rights of LGBTI persons are nullified as a critical first step towards protecting the rights of LGBTQ persons in Uganda.

### **APPENDIX: Cases of arrest still pending before police stations and courts across the country at the end of June 2025**

Currently, HRAPF is providing legal representation to a total of 16 individuals in 12 cases that are still pending actively either at various police stations or before various courts across the country. In 3 cases, 4 individuals are still reporting on police bond and answering various charges related to their sexuality and all the charges were preferred under the Anti-Homosexuality Act, specifically homosexuality. In 10 cases, 13 individuals are answering various charges, including homosexuality, promotion of homosexuality, aggravated homosexuality, indecent practices and having carnal knowledge against the order of nature/ indecent practices in the various courts of law. Of the 13 persons whose cases are pending before the courts, 6 are still on remand in the various prisons around the country. It is thus quite clear that the Uganda Police Force and the Office of the Director of Public

Prosecutions are still actively enforcing the Anti-Homosexuality Act, alongside the various provisions criminalizing same sex sexual behaviour in the Penal Code Act.
