## **1. Introduction**

This is the 28<sup>th</sup> monthly report on violence and other forms of human rights violations on the basis of sexual orientation and gender identity/expression since the Anti-Homosexuality Act (AHA) came into force on 30<sup>th</sup> May 2023. The report discusses cases in which known or suspected LGBTIQ persons were targeted for violence and violations purely on the basis of their SOGIE as reported in the month of September 2025. This report builds on the reports produced earlier for every month since the AHA came into force and therefore adds on to the data available about the enforcement of the AHA 2023 from 30<sup>th</sup> May 2023 to date.

## **2. Methodology**

This report provides an overview of cases of violence and human rights violations on the basis of SOGIE that were reported to the HRAPF legal aid network in September 2025. Quantitative data for this report was obtained from a review of case files for data on the number of cases handled and the number of cases in which acts of violence or other human rights violations were identified. The data was then subjected to a qualitative analysis to ascertain the circumstances under which the incidents occurred, in order to ensure that only cases in which such acts were perpetrated purely or primarily on the basis of real or presumed SOGIE are included in the report. All data reported has been independently verified to ensure its accuracy.

The data presented in this report covers only cases reported through the HRAPF legal aid network. The report therefore presents a fair picture of the situation for LGBTIQ persons across the country as reported to HRAPF's countrywide network of community paralegals, regional legal aid centres, specialised community legal aid desks and the main legal aid clinic, but it may not be representative of all LGBTIQ persons' lived realities during the month, as not all cases that occurred in September 2025 were reported to HRAPF's network.

## **3. Nature and number of cases reported**

HRAPF handled a total of 60 cases in the month of September 2025, a slight reduction from the 66 cases handled in the month of August 2025. 18 cases involved actions that directly targeted people for negative treatment on the basis of their SOGIE, representing 30% of all the cases handled during the month, the same number as for August 2025. However, owing to 3 targeted mass arrests of LGBTIQ persons in September 2025, the number of victims of these violations almost doubled, from 26 people in August 2025 to 41 people in September 2025.

Out of the 18 cases in which LGBTIQ people were specifically targeted for violent or otherwise detrimental treatment during the month of September 2025, 7 were cases of violence; 6 were arrests on sexuality-related charges and 4 were eviction cases. 1 case involved extortion of a suspected gay man by the local area leadership in the village where he lived.

This section of the report provides detailed data on these cases.

### 3.1. Cases involving actual violence and threats of violence

A total of 7 cases involving violence were registered in September 2025, affecting 9 individuals. 6 of the cases involved actual physical violence towards the victims due to their SOGIE while 1 involved sustained verbal abuse. Two of the cases were reported in Gulu while one case was reported from each of the districts of Apac, Mbale, Mbarara, Manafwa and Kampala. 5 of these incidents were perpetrated by unknown persons while 1 was perpetrated by police officers and 1 by family members.

### 3.2 Arrests

There were 6 cases reported in September 2025 in which 27 persons were arrested purely on the basis of their presumed SOGIE. This contrasts sharply with the statistics in August 2025 where 5 cases occurred with only 9 victims. September 2025 has brought back memories of mass arrests in the years preceding the AHA. Three groups of suspected LGBTQ persons were arrested in mass swoops.

Three of the incidents in this month were reported from Wakiso district, while one of the remaining three were reported from each of Kampala, Soroti and Kabarole districts. In 4 of the cases, the clients were charged with homosexuality while in one case, the victims were charged with being a common nuisance; in another they were charged with disappearance and in one case, no charges were preferred at all.

### 3.3 Evictions

There were 4 cases of evictions on the basis of sexuality in September 2025, affecting 4 persons. 2 cases were reported from Kampala, 1 case was from Wakiso while the other was from Kabarole district. In 2 of the cases, the evictions were orchestrated by family members; in 1 case, the eviction was initiated by the landlord while in the last case, the local area leadership worked with the landlord to evict the client from the village of residence.

### 3.4 Other forms of discrimination

In September 2025, 1 case of extortion against an individual on the basis of their sexuality was recorded. The incident was reported in Sironko district and was perpetrated by the local council leadership.

#### **4. Comparison with August 2025**

There was a reduction in the overall number of cases reported in September 2025, from 66 cases in August 2025 to 60 cases, but the number of cases in which individuals were targeted for violence and other violations on the basis of their SOGIE remained constant at 18 cases. However, the number of individuals affected by these actions increased significantly from 26 in August to 41 in September. Cases involving violence were the highest number of cases in August, where 8 incidents affecting 11 individuals were reported. This held steady in September, although the numbers slightly reduced to 7 cases affecting 9 individuals. Cases of arbitrary arrests of individuals on the basis of their SOGIE increased slightly from 5 cases in August to 6 cases in September, but the number of victims increased dramatically from 9 people in August to 27 persons in September 2025.

In a new disturbing twist, mass arrests resumed. Two raids were carried out in September on the private residences of suspected queer persons and the residents and visitors arrested on allegations of causing the disappearance of the same minor. In both of these cases, the facts simply were that a male juvenile had run away from home and his parent reported him missing at two police stations, with the additional information that they suspected he had run away to join a group of homosexuals. In both cases, the reaction of the police was to raid the homes of suspected queer people in their area, and in the end the arrested individuals were all released unconditionally as none of them even knew the minor in question. The third mass arrest was of 13 people who had been attending a friend's birthday party and were rounded up by police officers as they tried to leave the venue. The police had waited outside the venue to carry out this arrest. The entire group was released without charges after an attempt at extortion failed. These three mass arrests both point to particularly disturbing trend in the usual police profiling of LGBTQ persons for arbitrary arrests. Finally, evictions increased slightly from 3 affecting 4 people in August to 4 cases affecting 4 people in September 2025.

#### **5. Comparison with September 2024**

HRAPF handled a total of 72 cases in the month of September 2024, of which 16 cases involved actions that directly targeted people for negative treatment on the basis of their SOGIE, representing 22.2% of all the cases handled during the month of September 2024. It is worth noting that, while the overall number of cases handled reduced to 60 cases in September 2025, the number of cases in which individuals were targeted for detrimental treatment on the basis of their SOGIE actually increased from 16 cases in September 2024 to 18 in September 2025. Cases of arrests for sexuality related reasons increased drastically from 2 cases affecting 5 people in September 2024 to 6 cases affecting 27 people in September 2025; evictions on the basis of sexuality increased from 2 cases affecting 4 individuals to 4 cases affecting 4 individuals in September 2025, although cases involving violence reduced from 9 cases affecting 14 people in

September 2024 to 7 cases affecting 9 persons in September 2025. This shows that the situation for LGBTIQ people in September 2025 seems worse than that in September 2024.

### 6. Comparison with the pre-AHA period – September 2022

In September 2022, about 6 months before the Anti-Homosexuality Bill 2023 was tabled and about 10 months before the law was enacted, a total of 45 cases were handled involving LGBTIQ persons. Of these, 13 cases involved actions that directly targeted persons on the basis of their real or presumed SOGIE. The actions in these 13 cases affected a total of 13 people, and included 9 cases of real or threatened violence (a little more than the 7 cases recorded in September 2025), 3 evictions and 1 arrest. It is important to note that, while the AHA was not yet in force at this time, there was still heightened public outcry against homosexuality and increased media attention towards the LGBTQ community following allegations of ‘recruitment’ of people into homosexuality,<sup>1</sup> which would eventually culminate into the tabling of the AHB 2023 in February 2023.

### 7. The implementation of the AHA 2023 from 30<sup>th</sup> May 2023 to 30<sup>th</sup> September 2025

As the implementation of the AHA marks two years and three months, a total of 1,967 cases involving LGBTIQ persons have been handled across the HRAPF legal aid network, of which 911 cases (46.3%) involved actions that specifically targeted LGBTIQ people because of their sexuality, gender identity and sex development affecting a total of 1,216 persons.

The breakdown of all the cases involving SOGIE- motivated violence and violations so far is as follows:

## 8. Conclusion

Over the last 28 months, HRAPF has carefully monitored the human rights situation for LGBTIQ persons in the wake of the enactment of the AHA 2023, tracking the impact of the law on access to justice, SRHR, protection from violence and other aspects of the day to day experiences of LGBTIQ persons. It remains abundantly clear that, despite a notable reduction in the number of cases of violence and violations perpetrated primarily by non-state actors, the situation still remains dire for LGBTIQ persons, and the state institutions in the criminal justice sector continue to enforce the AHA 2023 in a way that prejudices the right to liberty for LGBTIQ persons across the country, despite slight improvements in the legal environment in April 2024. The only apparent solution to this impasse remains a complete overhaul of the legal framework to provide for specific protection from violence and human rights violations on the basis of real or presumed SOGIE, as required by African Commission Resolution 275.

**APPENDIX: Cases of arrests still pending before police stations and courts across the country at the end of September 2025**

Currently, HRAPF is providing legal representation to a total of 23 individuals in 15 cases that are still pending actively either at police stations or before various courts across the country. In 5 cases, 9 individuals are still reporting on police bond and answering charges of homosexuality. In 10 cases, 14 individuals are answering various charges, including homosexuality, promotion of homosexuality, aggravated homosexuality, indecent practices and having carnal knowledge against the order of nature/ indecent practices in various courts of law. Of the 14 persons whose cases are pending before the courts, 7 are still on remand in the various prisons around the country while 5 were released on bail.
