



**REPORT ON VIOLENCE AND VIOLATIONS BASED ON REAL OR PRESUMED SEXUAL ORIENTATION OR GENDER IDENTITY  
DURING THE MONTH OF OCTOBER 2025**

## **1. Introduction**

This is the 29<sup>th</sup> monthly report on violence and other forms of human rights violations on the basis of sexual orientation and gender identity/expression since the Anti-Homosexuality Act (AHA) came into force on 30<sup>th</sup> May 2023. The report discusses cases in which known or suspected LGBTIQ persons were targeted for violence and violations purely on the basis of their SOGIE as reported in the month of October 2025. This report builds on the reports produced earlier for every month since the AHA came into force and therefore adds on to the data available about the enforcement of the AHA 2023 from 30<sup>th</sup> May 2023 to date.

## **2. Methodology**

This report provides an overview of cases of violence and human rights violations on the basis of SOGIE that were reported to the HRAPF legal aid network in October 2025. Quantitative data for this report was obtained from a review of case files for data on the number of cases handled and the number of cases in which acts of violence or other human rights violations were identified. The data was then subjected to a qualitative analysis to ascertain the circumstances under which the incidents occurred, in order to ensure that only cases in which such acts were perpetrated purely or primarily on the basis of real or presumed SOGIE are included in the report. All data reported has been independently verified to ensure its accuracy.

The data presented in this report covers only cases reported through the HRAPF legal aid network. The report therefore presents a fair picture of the situation for LGBTIQ persons across the country as reported to HRAPF's countrywide network of community paralegals, regional legal aid centres, specialised community legal aid desks and the main legal aid clinic, but it may not be representative of all LGBTIQ persons' lived realities during the month, as not all cases that occurred in October 2025 were reported to HRAPF's network.

## **3. Nature and number of cases reported**

HRAPF handled a total of 56 cases in the month of October 2025, a reduction from the 60 cases handled in the month of September 2025. 15 cases involved actions that directly targeted people for negative treatment on the basis of their SOGIE, representing 26.8% of all the cases handled during the month, down from 18 cases (30%) recorded in September 2025. The victims of these violations in October were 24 persons, a significant reduction in number from 41 victims in September. Out of the 15 cases in which LGBTIQ people were specifically targeted for violent or otherwise detrimental treatment during the month of October 2025, 7 were cases of violence, affecting 8 people; 3 were arrests on sexuality related charges, affecting 11 people (one was a mass arrest of 9 people at once); 3 were evictions, affecting 3 persons; and 2 were other acts of discrimination affecting 2 people. This section of the report provides detailed data on these cases.

### 3.1. Cases involving actual violence and threats of violence

A total of 7 cases involving violence were registered in October 2025, affecting 9 individuals. 6 of the cases involved actual physical violence towards the victims due to their SOGIE while 1 case involved an assault and robbery. 3 of the cases were reported in Gulu; 2 cases were reported in Kampala; 1 case was reported in Mbale; and 1 case was reported in Wakiso. The violence in these cases was perpetrated by unknown persons in 3 cases; family members in 2 cases and members of the general community where the victims reside in 2 cases.

### 3.2. Arrests

There were 3 cases reported in October 2025 in which 11 persons were arrested purely on the basis of their presumed SOGIE, as compared to September 2025, where 6 arrests were recorded, affecting 27 persons. October was also marked with an increase in threats against suspected LGBTQ students in halls of residence at Makerere University, and in one particularly outstanding incident, a student was arrested by the police to protect them from the threat of lynching by their fellow students. Two of the incidents in this month were reported from Kampala district, while one was reported from Wakiso. In 2 of the cases, the clients were charged with homosexuality while in one case, the victim was charged with entering a building with intent to commit a felony, to wit, homosexuality.

### 3.3. Evictions

There were 3 recorded cases of evictions in the month of October 2025, affecting 3 individuals. 2 of the incidents were reported in Kampala while one was reported in Mityana district. In one of the incidents, the eviction was orchestrated substantively by the local area leadership while in the other 2, the evictions were orchestrated by the landlord.

### 3.4. Other forms of discrimination

During the month of October 2025, HRAPF also recorded 2 other cases involving other forms of discrimination against individuals on the basis of their SOGIE. In one of the cases, the client was subjected to cyber harassment and extortion by a friend who had found out about his sexuality while in the other, the client was abducted in an attempt to extort him for money.

#### **4. Comparison with September 2025**

There was a reduction in the overall number of cases reported from 60 cases in September 2025 to 56 cases in October 2025, and a corresponding reduction in the number of cases in which people were deliberately targeted for detrimental treatment on the basis of their SOGIE from 18 cases in September to 15 cases in October 2025. In both months, cases of violence on the basis of SOGIE were highest at 7 cases, but arrests for sexuality related reasons reduced from 6 in September to 3 in October 2025. It is worth noting that the trend of mass arrests of suspected LGBTQ persons continued in October, although there was a reduction with only 1 mass arrest recorded as compared to 3 in September 2025. Evictions also reduced slightly from 4 cases affecting 4 people to 3 cases affecting 3 people.

In a rather frightening series of events in October 2025, students at Makerere University, Uganda's largest public university started a witch hunt targeting their peers that they perceived as gay. Over a period of more than 2 weeks, students at the university exchanged lists of names and contacts of 'gay lords', physically assaulted 2 people (who reported the matter) and burnt the belongings of one student, who chose not to report but the perpetrators themselves reported this incident through social media. In one incident, the students formed themselves into a violent mob that attempted to lynch a fellow student and were only stopped by the police. They complained about the police's interference to the university management, and the situation only calmed down after the university leadership intervened and suspended the students involved in mobilising the mobs. In one incident, HRAPF lawyers who had accompanied one of the victims to Mitchell Hall to pick his property were also attacked, a laptop stolen and their car damaged.

This violent spike raises concerns about the safety of LGBTQ persons in institutes of higher education, but also in public spaces generally as the campaign season kicks off, with its usually associated spike in violence. It is commendable that the university's management responded decisively by suspending some of the ringleaders.

#### **5. Comparison with October 2024**

HRAPF handled a total of 50 cases in the month of October 2024, which is a little less than the 56 cases handled in October 2025. Out of the 50 cases handled in October 2024, 16 cases involved actions that directly targeted people for negative treatment on the basis of their SOGIE, representing 32% of all the cases handled during the month of October 2024, a slightly higher number than the 15 cases reported in October 2025 (26.8% of all cases reported in the month). The number of cases of violence on the basis of SOGIE dropped slightly from 9 cases affecting 10 people in October 2024 to 7 cases affecting 8 people in October 2025; the number of eviction cases also reduced slightly from 4 cases affecting 4 people in October 2024 to 3 cases affecting 3 people in October 2025; and the number of arrests for sexuality related reasons remained constant at 3.

While, on the face of it, these figures might appear encouraging, hinting at a slow reduction in targeted violence and violations, it must be noted that the trend of mass arrests documented in September and October 2025 were not present in the same period in 2024, and that the

recent spike in mob violence against suspected LGBTQ students is also a new phenomenon, thus indicating a regression rather than progress of any magnitude.

### 6. Comparison with the pre-AHA period - October 2022

In October 2022, a total of 53 cases were handled involving LGBTQ persons, of which 7 cases involved actions that directly targeted persons on the basis of their real or presumed SOGIE. The actions in these 7 cases affected a total of 7 people, and included 3 cases of real or threatened violence and 4 arrests for sexuality related reasons. While the total number of cases reported by LGBTQ persons is not significantly different between the 2 months, the number of cases in which individuals were targeted for negative treatment on the basis of their SOGIE more than doubled from 7 cases in October 2022, before the AHA came into force, to 15 cases in October 2025, indicating that the levels of violence and violations on the basis of SOGIE are still much higher presently than they were before the AHA came into force.

### 7. The implementation of the AHA 2023 from 30<sup>th</sup> May 2023 to 30<sup>th</sup> October 2025

As the implementation of the AHA marks two years and three months, a total of 2,023 cases involving LGBTIQ persons have been handled across the HRAPF legal aid network, of which 926 cases (45.8%) involved actions that specifically targeted LGBTIQ people because of their sexuality, gender identity and sex development affecting a total of 1,240 persons.

The breakdown of all the cases involving SOGIE- motivated violence and violations so far is as follows:

### 8. Conclusion

HRAPF has continued to monitor the human rights situation for LGBTQ persons in Uganda in the 29 months since the AHA came into force, and it is clear that violations of the rights of individuals on the basis of their SOGIE remain higher now than they were in the period before the AHA was enacted. The trend of police arresting suspected LGBTQ persons en masse for flimsy reasons remains a cause for concern, as does the recent spike in violence against suspected LGBTQ students at Makerere University, with both matters requiring close monitoring over the next few months.

**APPENDIX: Cases of arrests still pending before police stations and courts across the country at the end of September 2025**

Currently, HRAPF is providing legal representation to a total of 21 individuals in 14 cases that are still pending actively either at police stations or before various courts across the country as a result of arrests of real or suspected LGBTIQ persons. In 4 cases, 7 individuals are still reporting on police bond and answering charges of homosexuality. In 10 cases, 14 individuals are answering various charges, including homosexuality, promotion of homosexuality, aggravated homosexuality, indecent practices and having carnal knowledge against the order of nature/ indecent practices in various courts of law. Of the 14 persons whose cases are pending before the courts, 5 are still on remand in the various prisons around the country while 9 were released on bail.
